

## SCHOOL DISTRICT # 64 (GULF ISLANDS)

### BYLAW NO. 2

#### PROPERTY CONTROL

A Bylaw to regulate and control the use of property owned or administered by the board of School Trustees School #64 (Gulf Islands).

WHEREAS in accordance with the provisions of Sections 85 (4) and 93 of the Schools Act, the Board is empowered to make bylaws for the control and regulation of property owned or administered by the Board.

NOW THEREFORE, the Board of School Trustees of School District # 64 (Gulf Islands) enacts as follows:

1. No person shall drive any motor vehicle or ride any bicycle on or over any land owned or administered by the Board of School Trustees, School District #64 (Gulf Islands), (hereinafter called "The Board") except:

#### **Deliveries**

- (a) Any person proceeding to or from a public school on roadways provided for that purpose in the course of delivery or receiving chattels in connection with the operating of such school.

#### **Board**

#### **Employees**

- (b) Any person proceeding to or from a public school on roadways provided for that purpose in connection with his or her duties therein, or on other bona fide business pertaining to the operations of such school.

#### **Pupils**

- (c) Any person proceeding to or from a public school at which he or she is a registered pupil on roadways provided for that purpose unless the principal of such school denies such person permission to so proceed.

#### **Consent**

- (d) Any parent or guardian proceeding to or from a public school at which his or her child or ward, as the case may be, is a registered pupil, on roadways provided for that purpose, unless the Board denies such parent or guardian permission to so proceed.

#### **Other Persons**

- (e) Any other person proceeding to or from a public school on roadways provided for that purpose who has first received permission in writing from the Board.

2. No person shall:

#### **Speed Limit**

- (a) Operate any motor vehicle or ride any bicycle on or over land owned or administered by the Board at a greater rate of speed than fifteen (15) kilometers per hour.

#### **Parking**

- (b) Park or otherwise leave unattended a motor vehicle upon land owned or administered by the Board except in an area set aside for parking by the Board unless permission in writing to do so has been given by the Board.

**Trespassing**

- (c) (i) No person shall enter upon any property owned or administered by the Board except registered pupils and parents or guardians of such pupils, employees of the Board and such other persons authorized by the Board to be on such property.
- (ii) No person shall, upon the request of the Principal or any other person in authority, refuse to leave any property owned or administered by the Board. Any person so requested shall do so immediately and any disobedience of such a request shall be considered a breach of this bylaw.
- (iii) The Board authorizes Principals, Vice-Principals, all teachers and all custodians in its employ to make such directions and to follow such courses of action as deemed appropriate for the protection of pupils and maintenance of order, and the Board declares that this resolution constitutes an authorization pursuant to Section 93.2 of the School Act.

The order of authority under this authorization is as follows:

- (i) Principal, and in the event of his/her absence, a
- (ii) Vice Principal, and in the event of his/her absence, a
- (ii) Teacher, and in the event of his/her absence,
- (iv) Another employee

**Night Trespassing**

- (d) Trespass, cross over or loiter upon any land owned or administered by the Board between the hours of 1/2 hour after sunset and 1/2 hour before sunrise without the written permission of the Board unless entry is under authority of, or for purposes described in Section 2 (c) (i) of this bylaw.

**Animals**

- (e) Take or allow any domestic or range animal upon land owned or administered by the Board without the written permission of the Board.

**Complement to other Statute or Bylaw**

- 3. The provisions of this Bylaw shall not restrict the enforcement of the Public Schools Act, the Motor Vehicle Act or regulations pursuant to other thereto.

**Penalty**

- 4. Except as is otherwise provided in this Bylaw, any person contravening or committing any breach of, or committing any offence against any of the provisions of this Bylaw, or who refuses, omits or neglects to fulfill, observe, carry out or perform any duty, obligation, matter or thing whatsoever by this Bylaw prescribed or imposed or required to be done is liable, on summary conviction, to a fine not exceeding Five Hundred Dollars (\$500.00) OR to a term of imprisonment not exceeding thirty (30) days or both.

**Authority to Regulations**

- 5. The Board may cause to be erected devices to regulate, prohibit, control and direct vehicular and pedestrian traffic on land owned or administered by the Board.

6. This Bylaw shall come into force and take effect on and after third reading and adoption by the Board of School Trustees, School District # 64 (Gulf Islands).
7. This Bylaw may be cited for all purposes as School District # 64 (Gulf Islands) Property Control Bylaw No. 2 and is in all respects in accordance with the provisions of the "Schools Act".
