2. CORPORATE FINANCIAL OFFICER'S REPORT

(a) Monthly Expenditure Report

The monthly expenditure report, as at February 22, 2017, indicates that with 0.5833 of the year completed, 0.5362 of the budget has been expended. We are 4.7% below budget at this time. January was a high expenditure month with expected, one-time expenses totaling over \$2,000,000. Mr. Scotvold stated the district is in good shape for this time of year.

(b) Amended Annual Budget 2016/2017

Ms. Rodgers spoke in detail regarding the 2016/2017 Amended Annual Budget, with particular attention to:

- Schedule 2A – Operating Revenue by Source
 - An increase in Ministry revenue due mainly to an increase in student enrollment
 - Transportation grant of an additional \$328, 264
- Schedule 2B – Operating Expense by Source
 - An increase in salaries and benefits, due to the increase in student enrollment
 - Cost increases in Services and Supplies
 - Cost reduction in insurance
 - Cost reduction in Rentals and Leases due to the decrease in costs for the Windsor House School lease

For the Operations Fund (Schedule 2), Ms. Rodgers anticipates a balanced budget for the 2016/2017 school year.

This Amended Annual Budget of \$24,079,462 is a compilation of the Operating, Capital and Special Purpose Funds. It is to be submitted to the Ministry by the end of this month. Ms. Rodgers invites anyone to contact her if they have any questions or would like clarification on any points.

This draft budget was posted on the district website at <http://sd64.bc.ca/finance/> February 1, 2017.

The Amended Annual Budget Bylaw was read by Secretary Treasurer Rod Scotvold.

It was moved and seconded that there is unanimous approval to read the Amended Annual Budget Bylaw for 2016/2017 in one sitting.

(c) Student Learning Grant

An announcement was received from George Farkas, Assistant Deputy Minister dated February 20, 2017 regarding the Student Learning Grant. This grant is one-time funding to “help ensure that classrooms are well-resourced and students are well-supported through the implementation of the new curriculum and other learning innovations across the K-12 public education system.” The total provincial funding being provided to school districts in 2016/17 is \$27.4M, and is being allocated based on a calculation of \$50/student FTE. Eligible categories of resources/supplies include instructional supplies (e.g. electronic learning resources, textbooks, other classroom supplies serving an educational purpose), athletic equipment, and learning resources to assist non-enrolling teachers (i.e. career preparation materials). Any unspent funding from 2016/17 can be carried over to the 2017/18 school year; districts are to track how the funding is being utilized and report-out by July 31, 2017 school year to their District Parent Advisory Council.
